Voice of Change: Second Transnational Meeting



As part of the CERV project “**Voice of Change**”, the second transnational consortium meeting took place on June 5, 2025. Hosted by the **Fachhochschule des Mittelstands (FHM)** in Berlin, the event brought together 31 partners from 14 different EU countries.

The recent in-person meeting focused on **exchanging ideas** and making **key decisions** for upcoming project challenges, first identified during the September 2024 meeting in Rome. A highlight was the presentation of the **Guidelines for Drafting Policy Recommendations** by Dr. Rojda Subasi (FHM), which will guide the consortium in preparing the final report for the EU. Partners welcomed the document and agreed to contribute their insights through **five** scheduled online meetings, aiming to finalize the report by October 2025.

Partners introduced new dissemination strategies following the project’s strong online reception—over **1,000 website visits** to date. These include **national press releases**, **a new content plan for the second half of 2025**, and **regular updates via newsletters, social media, and website posts** showcasing the consortium’s progress and achievements.

Webinars Successfully Completed!

During the Berlin meeting, Federica Leto (Roma Tre University) presented an analysis of the **webinars** held between **February** and **March 2025**, attended by participants from each partner country and external guests. The sessions focused on **political and economic empowerment, leadership, and female entrepreneurship**, aiming to boost women's participation in society and the EU. With the final webinar held on **March 13**, this key phase is now complete, and the consortium is moving forward with upcoming project goals.
